**PROGRAM AREA:** Public Works - Lands  
**POSITION TITLE:** Beach Patrol Crew Member (two positions available)  
**REPORTING PROTOCOL:** Reports to the Beach Patrol Supervisor and Lands Manager

### POSITION SUMMARY:

The Beach Patrol Crew Member is a temporary full time summer position with Wasauksing First Nation, under the supervision of the Beach Patrol Supervisor and reporting to the Lands Manager. The Beach Patrol Crew Member will be responsible for assisting with the monitoring and maintenance of Wasauksing's beaches, issuing permits, assisting with the Wasauksing First Nation Powwow, Wasauksing First Nation Annual Youth Beach Clean-up Day Day, and Wasauksing's National Aboriginal Day Celebrations.

### DUTIES AND RESPONSIBILITIES:

- Patrol all Wasauksing First Nation beaches
- Perform regular grounds maintenance and garbage pick-up at the beaches (as required)
- Issue Land Use and Fishing Permits to non-members and collect permit fees
- Ensure all funds collected and permits issued are submitted to the Beach Patrol Supervisor
- Assist in the delivery of special events such as Wasauksing First Nation's Annual Powwow, Wasauksing First Nation's Annual Youth Beach Clean-up Day, and Wasauksing's National Aboriginal Day celebrations
- Exercise "positive public relations" at all times
- Follow all appropriate health and safety requirements of the position
- Ensure time sheets, reports, issued permits, and permit fees are submitted accurately and on time
- Must be willing to work weekends and evenings, as required

### QUALIFICATIONS AND EDUCATIONAL REQUIREMENTS:

- Experience operating a boat an asset (Pleasure Craft Operator Card will be required, we can assist you in obtaining your Operator Card if you don't already have one)
- Knowledge of Wasauksing waterways would be an asset
- Must be between 15 and 30 years of age and legally entitled to work in Canada
- Must have been registered as full-time student in the previous academic year and intend to return to school on a full-time basis in the next academic year
- Must not hold another full time summer job (30 hours or more)
- Ability to speak Ojibway is an asset
- Valid driver's license an asset and must be insurable under Band policies.
- Must provide current CPIC acceptable to the position upon conditional offer

**RATE AND CLASSIFICATION:** Rate of pay will begin in the Grade 0 Step 7 of the approved Salary Grid (\$14.07 per hour)
