## **COVID 19: Emergency Response Order # 3** **Amending Order**

June 4<sup>th</sup>, 2020. As we continue to respond to the unprecedented COVID-19 global pandemic, Chief and Council of Wasauksing First Nation will continue to follow and enforce the Emergency Response Orders with the following amendments to the Orders as part of Phase 1 of the re-opening of Wasauksing Lands.

Beginning 9am (EST) on June 5<sup>th</sup>, 2020; the following persons whose primary residence is within the Parry Sound District and have submitted all necessary documentation to the Wasauksing Emergency Response Team ([ert@wasauksing.ca](mailto:ert@wasauksing.ca)) and meet the conditions, as outlined in the 2020-0023 Wasauksing First Nation BCR, are permitted to enter Wasauksing Lands for the following purposes and at the following locations:

- Seasonal camping and docking purposes with advance reservations for a duration of at least 30 consecutive days at:
  - › **Wasauksing Marina and Campground located at 891 Oak Point Road**
  - › **Bay and Creek Campground located at 2334 Shingwak Road**
- Seasonal cottage use at a cottage property located within the Leased Lands (as defined in Emergency Order #2) Lots 1-72 inclusive. Plan 5061 C.L.S.R Lots 73-243 inclusive. Plan 5062 C.L.S.R and Lots 74-244 inclusive, Plan 51788 C.L.S.R

Application submissions are required, at minimum, two business days prior to the date of arrival on Wasauksing Lands for those seeking to enter Wasauksing Lands under the application. Written authorization from the Emergency Response Team will be required prior to arriving at Wasauksing Lands.

Phase 2 of the reopening of Wasauksing Lands, beginning June 15<sup>th</sup>, 2020 will include persons who reside outside of the Parry Sound District entering Wasauksing Lands to the above noted locations. Application approval through the Emergency Response Team and conditions of the 2020-0023 Wasauksing First Nation BCR to enter Wasauksing Lands will remain the same for Phase 2 applicants.

EMERGENCY RESPONSE ORDER #3 – AMENDING ORDER  
June 4, 2020

WHEREAS:

- A. Wasauksing First Nation Council (the "Council") enacted the *Temporary Emergency Response Law*, as amended by the *Temporary Emergency Response Law Amending Law* (collectively, the "Emergency Response Law");
- B. Wasauksing First Nation Council (the "Council") declared a State of Emergency on March 27, 2020 as a result of the imminent and serious threat to human health caused by the COVID-19 global pandemic;
- C. Wasauksing First Nation's Emergency Designates, in accordance with the Emergency Response Law, issued an Emergency Response Order on March 27, 2020 ("Order #1") and Emergency Response Order #2 on March 31, 2020 ("Order #2"), both as amended by Emergency Response Order #3 on June 4 2020 ("Order #3")(collectively, the "Emergency Orders"); and
- D. The Council wishes to amend the Emergency Orders in order that Phase I of the re-opening of Wasauksing Lands can commence on June 5, 2020 with the appropriate measures in place to preserve the health and welfare of Citizens and residents of the Wasauksing Lands,

NOW THEREFORE BE IT RESOLVED THAT

1. The word "temporary" shall be deleted from the last line of the chapeau at section 1 of Order #1.
2. Paragraph 1(g) and the post-amble below paragraph 1(g) of Order #1 shall be deleted and replaced with the following:
  - (g) any person or category of persons designated in writing by Council or by the Emergency Designate as:
    - (i) permitted to temporarily enter onto Wasauksing Lands for a specified purpose, or
    - (ii) permitted to enter onto Wasauksing Lands on a seasonal basis for camping and docking purposes, or for the use of a cottage located on property located within the leased lands legally described as Lots 1-72 inclusive, Plan 5061 C.L.S.R., Lots 73-243 inclusive, Plan 5062 C.L.S.R. and Lots 74-244 inclusive, Plan 51788 C.L.S.R, at a specified location, subject to any terms or conditions deemed necessary or appropriate by Council or an Emergency Designate to preserve the health and welfare of Citizens and residents of the Wasauksing Lands,

provided all such exempted persons take all reasonable and required precautions to avoid the spread of COVID-19 while they are on Wasauksing Lands and, with the exception of persons designated in accordance with sub-paragraph (g)(ii), leave Wasauksing Lands as soon as possible, or immediately after carrying out their required duties or business.

2. Paragraph 1(f) and the post-amble below paragraph 1(f) of Order #2 shall be replaced with the following:
  - (f) any person or category of persons designated in writing by Council or by the Emergency Designate as:
    - (i) permitted to temporarily enter onto Wasauksing Lands for a specified purpose, or
    - (ii) permitted to enter onto Wasauksing Lands on a seasonal basis for camping and docking purposes, or for the use of a cottage located within the Leased Lands, at a specified location, subject to any terms or conditions deemed necessary or appropriate by Council or an Emergency Designate to preserve the health and welfare of Citizens and residents of Wasauksing Lands,


provided all such exempted persons take all reasonable and required precautions to avoid the spread of COVID-19 while they are on Wasauksing Lands and, with the exception of persons designated in accordance with sub-paragraph (f)(ii), leave the Leased Lands and Wasauksing Lands as soon as possible, or immediately after carrying out their required duties or business.

3. For clarity, Order #1 and Order #2 shall remain in force and effect, subject to the changes set out at sections 1 and 2 of this Order.

**This Order is made and comes into effect on the 4th day of June, 2020, at Wasauksing, in the Province of Ontario.**
