WHEREAS:

- A. The Council of Wasauksing First Nation (the "Council") enacted the Wasauksing First Nation Temporary Emergency Response Law") and the Temporary Emergency Response Law Amending Law;
- B. The Council subsequently has enacted the Wasauksing First Nation Emergency Response Law, which it has enacted this 21st day of July, 2020 (the "Emergency Response Law");
- C. The Council determined, in accordance with the Temporary Emergency Response Law, that a state of emergency existed on Wasauksing First Nation reserve lands ("Wasauksing Lands") as a result of the imminent and serious threat to human health caused by the COVID-19 global pandemic (the "Pandemic");
- D. The Council declared a State of Emergency under the Temporary Emergency Response Law on March 24, 2020, and continued and renewed this State of Emergency on June 10, 2020 (the "First State of Emergency"); and
- E. The Council has determined, in light of the continuing Pandemic and its ongoing threat to human health, that it is in the best interests of Wasauksing First Nation to declare a State of Emergency in accordance with the Emergency Response Law (the "State of Emergency") and provide for the emergency measures required to preserve the health and welfare of Wasauksing First Nation Citizens and residents,

NOW THEREFORE BE IT RESOLVED THAT:

 An imminent health crisis exists as a result of the deadly effects of the Pandemic, which is circulating widely and freely throughout Ontario and the world and poses serious risk to the Citizens and community of Wasauksing First Nation
