EMERGENCY RESPONSE ORDER #6

WHEREAS:

- A. The Council of Wasauksing First Nation (the "Council") enacted the Temporary Emergency Response Law, as amended by the Temporary Emergency Response Law Amending Law;
- B. The Council subsequently enacted the Wasauksing First Nation Emergency Response Law, which it enacted on the 21st day of July, 2020 (the "Emergency Response Law");
- C. The Council declared a State of Emergency under the Temporary Emergency Response Law on March 24, 2020, and continued and renewed that State of Emergency on June 10, 2020 (the "First State of Emergency"), as a result of the imminent and serious threat to human health caused by the COVID-19 global pandemic (the "Pandemic");
- D. The Council subsequently revoked and replaced the First State of Emergency with a State of Emergency declared under the Emergency Response Law, dated July 21, 2020 (the "State of Emergency").
- E. Chief Warren Tabobondung and Deborah Pegahmagabow, Wasauksing First Nation Director of Health, have been authorized by Council to make orders and declarations in order to deal with the State of Emergency in accordance with the Emergency Response Law (the "Emergency Designates");
- F. The Emergency Designates, in accordance with the Temporary Emergency Response Law, as amended, issued Emergency Response Order #4 on June 11, 2020 ("Order #4"), which revoked and replaced the Emergency Response Order dated March 27, 2020, Emergency Response Order #2 dated March 31, 2020, both as amended by Emergency Response Order #3 dated June 4, 2020;
- G. The Emergency Designates then issued Emergency Response Order #5 on July 6, 2020 ("Order #5"), which revoked and replaced Order #4 in order that Phase II of the re-opening of Wasauksing Lands could advance;
- H. With this Emergency Response Order #6 (the "Order"), the Emergency Designates now consider it necessary to re-issue Order #5 in accordance with the Emergency Response Law, in order that Phase II of the re-opening of Wasauksing Lands can continue with the appropriate measures in place to preserve the health and welfare of Citizens and residents of the Wasauksing Lands; and

NOW THEREFORE:

The Emergency Designates hereby make the following Order:

- 1. Order #5 is hereby re-issued in accordance with the Emergency Response Law.
- This Order comes into effect on the later of the date the State of Emergency comes into effect and the date this Order is made, and remains in effect while the State of Emergency is in effect, unless earlier revoked by Council or an Emergency Designate in accordance with the Emergency Response Law.

This Order is made on the 21st day of July, 2020, at Wasauksing, in the Province of Ontario.
