### National Native Alcohol & Drug Abuse Program (NNADAP) Worker

The Wasauksing First Nation-Health Department is seeking an innovative, highly motivated and energetic team player for the position of National Native Alcohol & Drug Addictions Program Worker Position. You will be a valued member of the Program Prevention team in the Wasauksing First Nation.

The National Native Alcohol and Drug Abuse Program (NNADAP) Worker is responsible for providing substance abuse awareness, education, information to community members; school age children and the youth. Assist those looking for access to treatments centres.

A requirement of this position is to work with the Indigenous Primary Care Team (IIPCT) for support of "harm reduction model of treatment" and most importantly referral to both Indigenous & non-Indigenous Treatment Centres.

Applicants must possess an Ontario Secondary High School Diploma/GED with minimum academic requirements and/or possess a college diploma or equivalent in health/social services with 2 year community experience. Any experience in an Indigenous environment or other Indigenous services/agencies. Have current certification in CPR-AED/First Aid or be prepared for re-certification and be willing to gain further education as required.

Other requirements of the job will be that the successful candidate be able to work independently; provide an acceptable Criminal Records Check and Vulnerable Sector Check-Level 3; proof of a minimum class "G" driver's licence and abstract.
