Wasauksing First Nation Animal Care & Control By-Law

Guided by the Seven Grandfather Teachings

Preamble

We, the Chief and Council of Wasauksing First Nation, grounded in our inherent right to self-govern and guided by our sacred teachings, enact this by-law to ensure the well-being, safety, and respectful coexistence between our people and the animals that live among us. Our teachings—Wisdom, Love, Respect, Bravery, Honesty, Humility, and Truth—guide our decisions and this law.

1. Name of the By-Law

This law is called the Wasauksing First Nation Animal Care & Control By-Law.

2. Purpose

- Protect community members and visitors from harm.
- - Ensure animals are cared for with love and respect.
- Prevent animals from becoming a danger or nuisance.
- - Encourage responsible ownership in a good way.

3. Definitions

Plain language terms have been added to explain key words. (Definitions such as "Animal Control Officer," "dangerous animal," "owner," etc. remain mostly the same, but are simplified for clarity and understanding.)

4. Animal Control Officer

Chief and Council may appoint a kind, respectful, and trained person to oversee animal registration, enforcement, and care.

5. Registration & Identification

- All cats and dogs must be registered each year by March 1.
- All animals must wear a tag provided by the Nation.
- Owners must register new animals within 2 weeks of arrival or 8 weeks of birth.
- Fees help support the care of animals and are set by Council (See Schedule A).

6. Vaccinations & Health

- All pets must be vaccinated against rabies and cared for properly.
- If an animal is exposed to rabies or bites someone, it may be quarantined.
- Rabid or dangerous animals may need to be put down in a humane and respectful way.

7. Dangerous or Restricted Animals

- Some animals may be designated as dangerous or restricted if they bite, attack, or show aggression without cause.
- Restricted breeds (like Pit Bulls) are not allowed unless they were already owned before this law. These animals must be muzzled and leashed at all times when outside.

8. Right to Appeal

- An owner has the right to appeal a dangerous or restricted designation.
- - A neutral committee will review and decide within 5 business days.

9. Keeping Animals Safe & Respectful

- - Animals must not run freely or enter others' property without permission.
- Owners must clean up after their animals.
- Animals that damage property or hurt others must be controlled.
- - No animal should be left to bark, growl, or disturb the peace.
- · Animals must not be mistreated or abused in any way.

10. Animal Control in Specific Areas

Chief and Council may designate specific areas within Wasauksing First Nation where animals are not allowed for health, safety, or cultural reasons.

- Notices will be posted at the Wasauksing First Nation Government Office, on local radio, and signage placed at the site.
- After notice is given, no person shall keep or bring animals into the restricted area.
- No animal boarding or treatment facility may be established without written approval by Chief and Council.

SPCA Support Clause:

Until Wasauksing establishes its own enforcement and care processes, the Society for the Prevention of Cruelty to Animals (SPCA) may be called upon to support enforcement, impoundment, or animal welfare services, as needed and in alignment with this by-law.

11. Seizing & Impounding Animals

- - Animals running at large or acting aggressively may be impounded for at least 5 days.
- Owners will be notified and given a chance to reclaim their animal.
- Animals not claimed may be adopted out or humanely put down.
- Injured or extremely dangerous animals may be destroyed immediately to protect others.

12. Destruction Without Seizure

If an animal cannot be caught and poses danger, it may be destroyed. This is done only after every reasonable effort is made.

13. Immediate Protection from Harm

Animal Control or Police may destroy an animal without notice if it is attacking a person, another animal, livestock, or equipment.

14. Penalties

First offence: \$200Second offence: \$300Third or more: \$500

15. Licensing Fees

Council will update license fees as needed and post them publicly in Schedule A.

16. Final Words

This law exists to promote harmony between humans and animals. It is rooted in our teachings, and it respects all living beings as part of Creation. We trust that by working together, we can ensure a safe, caring, and respectful community for all.

Wasauksing First Nation

Being a band within the meaning of the *Indian Act*

Wasauksing First Nation Animal Control By-Law

Enacted this ____ day of

WHEREAS the Wasauksing First Nation has and recognizes the inherent right of self-government and jurisdiction to pass laws to provide for the health and safety of the residents on and visitors to the Wasauksing First Nation Territory, the prevention of nuisances, the protection against and the prevention of trespass by domestic animals, matters arising out of or ancillary to the exercise of powers under this section, and the imposition of a penalty for the violation of any such laws;

AND WHEREAS the Chief and Council of the Wasauksing First Nation are of the opinion that the uncontrolled ownership, breeding and running at large of animals may be detrimental to the health and safety of the residents on or visitors to the Wasauksing First Nation Territory, and a nuisance to such residents or visitors;

NOW THEREFORE the Chief and Council of the Wasauksing First Nation enact a law as follows:

1. Short Title

This law may be cited as the "Wasauksing First Nation Animal Control By-Law".

2. Interpretation

In this law:

- 2.1 "animal" means dog, cat or any domestic or other animal, kept on Wasauksing First
 Nation Territory by any person.
- 2.2 "Animal Control Officer" means a person appointed pursuant to section 3, or any Wasauksing First Nation By-Law Enforcement officer and includes an Officer of the First Nation Police Services and a person employed by the Chief and Council of the Wasauksing First Nation, plus a Society for the Prevention of Cruelty to Animals(S.P.C.A.) Agent for the purpose of enforcing this law as necessary;
- 2.3 "animal register" means the register kept by the Animal Control Officer for the purpose of the registration of all dogs, cats and other domestic/wild animals on the Wasauksing First Nation Territory
- 2.4 "at large" or "running at large" means:
 - (a) off the premises of the owner; or
 - (b) not under the control of any person and in any event not on a leash
- 2.5 "band" means the Wasauksing First Nation Chief and Council
- 2.6 "cat" means any cat, male, or female, over the age of twelve(12) weeks)

- 2.7 "animal pound" means the animal shelter designated by Chief and Council of the Wasauksing First Nation
- 2.8 "council" means the Council of Wasauksing First Nation as defined by the *Indian Act*
- 2.9 "dangerous animal" is an animal, domestic or wild that, in the absence of any mitigating factor(s) has:
 - (a) attacked, bitten, or caused injury to a person or has demonstrated a propensity, tendency or disposition to do so as solely determined by Wasauksing First Nation Animal Control Officer;
 - (b) significantly injured another domestic animal; or
 - (c) an animal previously designated as a potentially dangerous animal, that is kept or permitted to be kept by its owners in violation of the requirements for such an animal;
- 2.10 "dog" means any dog, male or female, over the age of twelve (12) weeks;
- 2.11 "dwelling" means each single unit being a fully detached home, a semi-detached home, a multiple attach home, an apartment, trailer, tent and any building, facility or vehicle used or intended to be used for human habitation and in which normal domestic functions may be carried on:
- 2.12 "environmental officer of health" means the environmental officer of health providing service(s) to the Wasauksing First Nation;
- 2.13 "mitigating factors(s)" means a circumstances which excuses aggressive behaviour of an animal especially if the animal is a dog and, without limiting the generality of the foregoing, may include circumstances where:
 - (a) the dog/animal was, at the time of the aggressive behaviour, acting in defence of an attack from a person or other animal;
 - (b) the dog/animal was, at the time of the aggressive behaviour, acting in defence of its young or to a person or other animal trespassing on the property of its owner; or
 - (c) the dog/animal was, at the time of the aggressive behaviour, teased, provoked or tormented;
- 2.14 "muzzle" means a humane fastening for covering device that is:
 - (a) of adequate strength placed over the animal's mouth to prevent it from biting;
 - (b) approved by the Animal Control Officer.
- 2.15 "owner" means a person who possesses an animal and, where the owner is a minor, the person responsible for the custody of the minor is deemed the owner.
- 2.16 "reserve" means the Wasauksing First Nation
- 2.17 "warning" means to notify a person in advance that if the behaviour of the animal continues then the animal will be impounded.
- 2.18 "responsible contact" means a person, who has been identified as the next "responsible contact" by the animal owner.

3. Animal Control Officer

- 3.1 The Council may appoint by Band Council Resolution an Animal Control Officer to provide for the administration and enforcement of this law, including to receive registration and to issue identification tags.
- 3.2 The Council may, by way of motion, provide for reasonable remuneration to be paid to the

Animal Control Officer for services rendered and recorded.

4. Registration and Identification of animals

- 4.1 Every owner of a dog and/or cat shall annually on or before the first of March have their dog and/or cat registered, numbered, described and licensed at the **Wasauksing First Nation** Government Office or any other such place as designated by motion of Chief and Council.
- 4.2 Every person keeping more than one dog and/or cat per household shall have a registration tag placed around the neck of each dog.
- 4.3 Every dog and/or cat born on the **Wasauksing First Nation** Territory shall be licensed and registered by its owner within eight (8) weeks after its birth.
- 4.4 Every dog and/or cat brought onto the **Wasauksing First Nation** Territory shall be licensed and registered by its owner within two (2) weeks of being brought onto the reserve.
- A fee payable for each license shall be in accordance with Schedule A of this Law as amended from time to time and shall be due annually on or before the first of March.
- 4.6 Upon payment of a license fee for a dog and/or cat, the owner shall be furnished with a dog or cat tag bearing a serial number and the year in which it was issued and shall be kept securely attached to the dog at all times until the tag is renewed or replaced.
- 4.7 The tag may be removed from the dog while it is being lawfully used for the purpose of hunting.
- 4.8 A replacement tag may be obtained and a fee payable according to Schedule A.
- 4.9 It is an offense to use a tag on any other dog/cat than the dog/cat that the tag is registered to.

5. Immunization of Animals

- 5.1 All domestic animals must be immunized in accordance with generally accepted veterinary standards.
- 5.2 The owner of any animal exposed to rabies shall, on demand of the Animal Control Officer or Chief and Council, surrender the animal to be held in quarantine for a period of ten(10) days and such animal shall not be released without the written approval of medical officer of health, governed by Health Canada.
- 5.3 An owner upon demand of the Animal Control Officer or Chief and Council, shall surrender such
 - animal which has bitten any person in an unprovoked attack.
- Any animal found to be infected with rabies shall be destroyed by its owner or by the AnimalControl Officer at the expense of the owner.

6. Designating Potentially Dangerous, Dangerous or Restricted Animals

- 6.1 Where the Animal Control Officer designates an animal as potentially dangerous or dangerous, the Animal Control Officer shall serve written notice upon the owner requiring that the owner comply with the following requirements:
 - (a) to keep the designated animal confined within the owner's dwelling and under effective control of an adult or in an enclosed pen constructed with a secure top, sides and either a secure bottom effectively attached to the sides or the sides embedded in the ground to a minimum depth of 30 centimetres (1 foot), or as otherwise approved

- by the Animal Control Officer in accordance with s. 6.1;
- (b) to keep the designated animal under the effective control of an adult and under leash that is approved by the Animal Control Officer and not to exceed 1.8 meters (6 feet) in length, at all times when not confined;
- (c) to securely attach a muzzle as defined in s. 2.14 to the designated animal at all times when not confined in accordance with s. 6.1 (a);
- (d) to provide the Animal Control Officer with the new address and telephone number of the owner within two(2) working days of moving the designated animal;
- (e) to provide the Animal Control Officer with the name, address and telephone number of the new owner within two(2) working days of selling or giving away the designated animal;
- (f) to advise the Animal Control Officer with two(2) working days of the death of a designated animal;
- (g) to advise the Animal Control Officer forthwith if the designated animal running at large or has bitten or attacked any person or animal.
- 6.2 No person shall own or keep a restricted breed. Restricted breeds of dogs are as follows:
 - (a) Pit bulls;
 - (b) Breeds related to the Pit Bull;
 - (c) any other breed or mixed-breed animal as deemed by Chief and Council.
- 6.3 All restricted breeds currently owned by members of **Wasauksing First Nation** as of the date of the passing of this law are exempt from section 6.2 only with respect to the ownership of a current animal(s), provided that such animal(s) is registered with **Wasauksing First Nation** in accordance with this Law, and no further off-spring of such animals or future ownership of a restricted breed shall be allowed.
- 6.4 Any animal(s) qualifying as exempt under section 6.3 must be muzzled at all times when outside of the owner's dwelling and tethered and leashed in accordance with the provisions of this law. Failure to comply with this section or this law may result in an order by the Animal Control Officer to remove or destroy the restricted animal without notice to the owner.
- 6.5 The Animal Control Officer may, without notice to the owner, immediately destroy an animal which is a restricted breed.

7. Notice

- 7.1 The notice referred in s.6.1 shall include:
 - (a) a statement that the Animal Control Officer has reason to believe that the animal is a potentially dangerous, dangerous or restricted dog/animal;
 - (b) The requirements that the owner must comply with in accordance with this law and when such requirements take effect and;
 - (c) a statement that the owner may request, within seven(7) working days of the receipt of notice and is entitled to a hearing by a committee designated by Chief and Council of Wasauksing First Nation which may affirm or rescind the designation and the committee may substitute its own designation or requirements that the owner must comply with pursuant to s.8.1 of this law.

8. Appeal

- Where the owner of that animal receives notice from the Animal Control Officer designating an animal as potentially dangerous, dangerous or restricted, requests in writing to Chief and Council of Wasauksing First Nation, within three(3) working days of such notice, a committee to be known as the Appeal Committee shall hold a hearing within five (5) working days after receipt of the written request for a hearing and such committee may:
 - (a) affirm or rescind the Animal Control Officer's designation of the animal;
 - (b) substitute its own designation of the animal and/or
 - (c) substitute its own requirements of the owner of an animal.

However, during the appeal period, the owner must keep the animal contained to the owner's dwelling and comply with any other term or condition with the exception of destruction.

8.2 An "Appeal Committee" is to be made up of individuals as deemed by Chief and Council for purposes of the specific appeal(s) within the five (5) working days after receiving notice by the owner requesting the appeal.

9. Inquiry

9.1 The Animal Control Officer may, either on his/her own initiative or as a result of a complaint received from a resident or visitor to the Wasauksing First Nation Territory, conduct an inquiry into whether an animal should be designated a potentially dangerous, dangerous or restricted.

10. Serving Notice(s)

10.1 Any notice(s) served by the Animal Control Officer or, requests for hearings made by an owner pursuant to this law shall be made by hand delivery or drop-off to a "responsible contact".

11. Prohibitions Within Specific Areas of the Wasauksing First Nation Territory

- 11.1 Chief and Council may, at any time, prohibit the keeping of animals within any area of the Wasauksing First Nation Territory.
- 11.2 Notice of any prohibition made by Chief and Council shall be posted in the **Wasauksing**First Nation Government Office; notice placed on local radio; signage placed at the site
 and after the date of posting, no person shall keep or have an animal in the prohibited
 area.
- 11.3 No person shall establish, own or operate a facility for the purpose of boarding or treatment of animals without the express written authorization from Chief and Council by way of motion.

12. Impounding and Seizures

- 12.1 No owner shall permit an animal belonging to him/her to be at large on the **Wasauksing** First Nation Territory.
- 12.2 An animal found to be at large on the Wasauksing First Nation Territory may be impounded for not less than five (5) days and after that be humanely destroyed or otherwise disposed of, unless such animal has been claimed by its owner and the costs incurred for the impounding of the animal have been paid.
- 12.3 An Animal Control Officer may seize any animal from any person whom he/she has reasonable cause to believe is violating, or has violated or is about to violate any provisions of this law.
- 12.4 If animal is apprehended because it has inflicted a bite upon an animal or human, the Animal Control Officer shall impound the animal for such a period of time to be specified by the Animal Control Officer.
- 12.5 Upon impounding an animal, the Animal Control Officer shall:
 - (a) notify the owner in writing or by telephone;
 - (b) the written notification must be hand delivered or sent by registered mail if owner not available:
 - (c) In the event that the registered owner is not available—hand delivered notice will be given to another adult deemed as a "responsible contact"; and
 - (d) the notification shall advise of the following:
 - impounding of the animal;
 - the hours during which the shelter is open;
 - the fee necessary to reclaim the animal;
 - the possible disposition of the animal if not reclaimed; and
 - the date by which the animal must be reclaimed.
- 12.6 Subject to s.12.2 an Animal Control Officer who has seized an animal pursuant to s. 12.3 shall restore possession of the animal to its owner where:
 - (a) date of seizure;
 - (b) the owner pays all expenses incurred in securing, caring for and feeding the animal;
 - (c) where the owner has failed to purchase an identification tag, he/she obtains the registration identification from the Animal Control Officer before he/she obtains the release of the animal.
 - 12.7 Where an animal has not been claimed within the specified period of time, the Animal Control Officer or the designated animal pound, may humanely destroy or dispose of the animal and no damages or compensation may be recovered as a result.
 - 12.8 Whereas in the opinion of the Animal Control Officer an animal seized under this section of the law is injured or should be destroyed immediately for humane reasons, or is for reasons of health or safety of other animals or humans, shall destroy the animal as soon as he/she deems fit without permitting any person to claim the animal and no damages or compensation may be recovered on account of such action.
 - 12.9 When an animal has been impounded, the Animal Control Officer shall make every reasonable effort to notify the owner of such animal.
 - 12.10 A written report of every such incident in this section shall be filed with Chief and

Council.

13. Destruction Where Unable to Scize

- 13.1 Where the Animal Control Office, after reasonable effort, is unable to seize an animal that is running at large contrary to the provisions of this law, he/she may destroy the animal.
- 13.2 No damages or compensation may be recoverable as a result of the destruction of an animal pursuant to s. 19.1.

14. Protection From Dogs

- 14.1 Any Animal Control Officer or Wasauksing First Nation Police may immediately and without notice to the owner destroy an animal that is running at large and is in the act of pursuing, attacking, injuring, damaging, killing or destroying;
 - (a) a person
 - (b) another animal
 - (c) a food cache, harness or other equipment, or
 - (d) domestic livestock.

15. General

- 15.1 Every owner of an animal shall keep the animal safely tethered or penned up at all times.
- 15.2 An animal, in this case a dog need not be tethered or penned up if the dog:
 - (a) is being used by a person for the purpose of hunting;
 - (b) is being used by a person to work in a lawful manner with sheep or cattle; or
 - (c) is used by a visually impaired person as a guide dog.
- 15.3 The owner of an animal who fails to take all necessary measures to ensure that such an animal does not enter upon the property of another person without being under the control or in the possession of the owner is guilty of an offence.
- 15.4 The owner of an animal which causes damage to any property including movable property, lawns, flower beds, bushes or plants or other parts of property, is guilty of an offence.
- 15.5 The owner of an animal shall, when the animal is on public property or private property belonging to another person, immediately pick up and thereafter dispose of any feces, vomit or other waste left by the animal on the said property.
- 15.6 Where a potentially dangerous, dangerous or restricted animal has been impounded for any reason, the Animal Control Officer shall not restore the said dog to its owner or any other person unless the Animal Control Officer is satisfied that the person to whom the dog is to be restored is aware of and in compliance with the provisions of this law.
- 15.7 The Animal Control Officer shall keep a record of every animal impounded or seized under this law, including a description of the animal, the license and the tag number and the date of disposition and the disposition made.

- 15.8 Whereas the owner of a designated animal which has been impounded is unable to demonstrate of the Animal Control Officer, or refuses to do so, the Animal Control Officer or designated animal pound may, after a reasonable period of time;
 - (a) dispose of the animal in a humane manner;
 - (b) sell the dog for such a price as the Animal Control Officer deems reasonable, for the recovery of costs incurred by Wasauksing First Nation in the impounding and holding of the animal, the money from such a sale shall belong to the Wasauksing First Nation.
- 15.9 Any animal impounded not wearing a tag for the current year may be given an inoculation to provide immunization against rabies and this inoculation can only be given by a veterinarian.
- 15.10 Wasauksing First Nation, its Chief and Council; employees and contracted employees and the Animal Control Officer shall not be liable for damages or compensation for any animal destroyed or seized under the provisions of this law and no such damages or compensation shall be paid to any person.
- 15.11 No owner shall permit an animal to bark, yelp and growl or otherwise annoy or disturb the peace of the residents of the Wasauksing First Nation.
- 15.12 No person shall punish or abuse an animal in a manner or to an extent that it is cruel or unnecessary.

16. Penalties

16.1 Every person who contravenes any provision of this law is liable for a fine of two hundred dollars (\$200.00) for a first offence, three hundred dollars (\$300.00) for a second offence and five hundred (\$500.00) for each offence thereafter.

17. Fees for Licences

- 17.1 Fees are determined from time to time under this law by Chief and Council.
- 17.2 Fees are located in Schedule "A" attached to this by-law.





Article I: General

Section 1. The Confederation will be known as the Bodewadmi Confederation of Tribal Nations. Section 2. The purpose of this Confederation is to:

- a. Promote unity, cooperation, and mutual support among Nations, and to advance the interest and well-being of its citizens and indigenous peoples.
- b. Maintain the sovereignty and self-determination of all member Nations.
- c. Coordinate collective decisions on matters of external relations at the international, federal, state, and provincial level.
- d. Promote unity, cultural continuity and survival among Bodwedmi peoples.
- e. Protect our ancestral territories from encroachment and environmental harm.

- Priority Areas Discussion Breakouts. All Councils broke up into groups and drafted ideas in the following areas for development.



The month of June was busy with Chiefs Assemblies both the Anishinabek Nation and the Chief's of Ontario were held this month. The Assembly of First Nation's gathering in Manitoba was postponed to the fall due to the fires. There was plenty of opportuntity to be proud to be Anishinaabe with Anishinaabe Gizhat and National Indigenous Peoples Day Celebrations this month. I attended a demonstration in Ottawa against Bill C-5 in June with a small but mighty contigent from WFN!



Administration Briefing on the most pressing issues that impact the community:

Finances: Audit Presentations still continue to be delayed from Administration. Today we finally received the draft 22/23 Audit. We look forward to planning a all members meeting to present the audit and combine a OLG info session to look at new priorities



Robinson Huron Litigation Fund meeting on June 24th regarding planning a Summer info session on the go forward issue with Annuities. The Chief and Council have sent letters to both Premiere Ford and Prime Minister Carney to encourage progress and to negotiate.

RHT Trust and Mitigo Min Trust progress has been slow at the Administration level. Chief and Council continue to pressure Administration based on Community feedback for a presentation and next steps. All funds are sitting in Trust and are awaiting community decision making.

Raciem is alive and well as Premier Dong Ford made these comments in regards to the First Nations of Onlano. It was invited to Queens Park to sit with the Premier as well the la contingent of Chiefs led by the Anishmanbek Nation's Grand Connel Gimankive Linda Debassige to meet in council and discuss our concerns over Bill 5 and more importantly his racist remarks made in the Media. As a collective we shared our disappointment and disgust to the harmful remarks to our People. We reminded him of Treaty Relationships.

 The Chiefp of Ontario Cathering in Hinwatha First Mation to celebrate the 50 years of advirously. Repolitions involved all areas from Health, Social, Economic Development and of Course our Opposition to the Federal Bill C-5 we teok a day to go to Ottawa to Protest on Parliament Hill. It was inspiring to hear from the panel of former Regional Chiefs discuss the eras of political advocacy. This included Constitutional Reform in the 80's, the Oka Crisis in the 90s, Burnt Church Crisis in the late 90's, Topperwish Crisis and the killing of Dudley George. To more current issues including the attack on Indigenous Rights and Free and Informed Prior Consent as well the HNDRIP principles being upheld Internationally.



Healing and wellness continue to be on the top of my mind. June was a difficult month as we seen more loss. We continue to need to be united in our struggles and grief. Our Ancestors are there to help us but we need to honour and have ceremonies to invoke spirit. This is what separates us in the world and what makes us unique, it's our Identity. 15 years ago the Chiefs of the Robinson Huron asked for guidance through Shake tent. The response was we have another way to look at wealth.

Rights and Responsibilities:



I am humbled to be in this position as it has a tremendous responsibility to uphold our rights and speak for the people. I am not here to make decisions on your behalf, I am here to listen to the Anishinaabek of Wasauksing and act accordingly. Despite the harse reality of being Anishinabe, I take pride and hope this month from attending celebrations and seeing our future through our Children and Youth. As a Nini I uphold my role to protect and provide for our community the best I can. We are a collective not individuals. The Chiefs of the RHW heard from Shake tent again and what we were told by our Ancestors to imagine that binojii 7 generations ahead, really see in your mind's eye what they look like. Make decisions today for them. This will be a challenge for leadership and each of us during the 7th fire.
